**AN ORDINANCE OF THE MUNICIPALITY OF MURRYSVILLE,
COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA
AMENDING ORDINANCE NO. 1012-19, FIXING THE TAX RATE FOR THE YEAR 2020**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Municipality of Murrysville, County of Westmoreland, Commonwealth of Pennsylvania

That a tax be and the same is hereby levied on all real property within the Municipality of Murrysville subject to taxation for the fiscal year 2020 as follows:

Tax rate for general purposes, the sum of 8.75 mills
On each dollar of assessed valuation or the sum of875 cents
On each one hundred dollars of assessed valuation.

Tax rate for Capital Improvement purposes, the sum of950 mills
On each dollar of assessed valuation or the sum of095 cents
On each one hundred dollars of assessed valuation.

Tax rate for road improvement purposes, the sum of500 mills
On each dollar of assessed valuation or the sum of050 cents
On each one hundred dollars of assessed valuation.

Tax rate for debt purposes, the sum of 1.25 mills
On each dollar of assessed valuation or the sum of125 cents
On each one hundred dollars of assessed valuation.

Tax rate for fire equipment purposes, the sum of600 mills
On each dollar of assessed valuation or the sum of060 cents
On each one hundred dollars of assessed valuation.

For hydrant purposes within 600 feet, the sum of100 mills
On each dollar of assessed valuation or the sum of010 cents
On each one hundred dollars of assessed valuation.



Tax rate for Capital Improvement purposes	0.95 Mills	.095 Cents
Tax Rate for Road Improvement Purposes	0.50 Mills	.050 Cents
Tax Rate for Debt Purposes	1.25 Mills	.125 Cents
Tax Rate for Fire Equipment and For Hydrant Purposes	<u>.10 Mills</u>	<u>.010 Cents</u>
TOTAL	12.15 Mills	1.215 Cents


